26th WORLD CONGRESS OF POLITICAL SCIENCE, LISBON, PORTUGAL

Postponing the IPSA World Congress to July 2021 will ensure a fruitful and safe Congress experience for everyone. In the meantime, we would like to thank all of you who invested time and effort into this Congress, and express our appreciation for your ongoing commitment in the upcoming months. All accepted papers and panels remain in the 2021 Congress program. We encourage all our delegates to keep their paper and panel submissions in the program. From the enthusiastic response we received, we were expecting a historic record number of delegates in July. We hope to see you all in Lisbon in 2021, in what promises to be a prominent and successful IPSA World Congress.
